Dear Mr. Christiansen:

The Federal Railroad Administration (FRA) is writing to inform you that the above-referenced quiet zone is in conditional compliance with the FRA quiet zone requirements in Title 49 CFR Part 222. FRA granted the petition for waiver (Docket Number FRA-2024-0124) on this day, and is in effect for one year.

This letter acts to notify the Cities of Salt Lake City, North Salt Lake, Woods Cross, West Bountiful, Kaysville, Layton, Clearfield, Clinton, Sunset, Roy, Ogden City and all railroads operating through the highway-rail grade crossings listed above that routine locomotive horn sounding should be silenced at these crossings within 7 days after receipt of this letter, per § 222.23(b)(4).
